Government support scheme



Energy Bill Relief Scheme (EBRS), which is for non domestic customers and as you'd expect is different from the Energy Price Guarantee (which is for households). If in doubt please direct clubs to this link on the GOV.UK site

Eligibility - scheme available to clubs on a non-domestic contract, who are:

- on existing fixed price contracts that were agreed on or after 1 December 2021
- signing or about to sign new fixed price contracts
- on deemed / out of contract or variable tariffs
- on flexible purchase or similar contracts

Discounts will be applied to energy usage initially between 1 October 2022 and 31 March 2023, with a review of the scheme after three months.


The support will be automatically applied to all eligible bills. Clubs do not need to take action or apply to the scheme.

Advice for clubs



New partner **Pozitive Energy** keen to support clubs, they have a specific 'Rugby' page on their website, with key contact details. Two offers for clubs (more details in the next group of slides).

Whilst **ZTP** continue to offer their broker service, at the moment due to the market volatility, they're struggling to obtain contracts, never mind a range of competitive offers. Under normal circumstances they would be able to shop around and try to find the best deal at that point in time for a club (which could be better than Pozitive Energy's offer).

Our advice at this stage for club's who are out of, or soon to be out of, contract is to use a blanket approach and contact the teams at **Pozitive** and **also ZTP**, plus speaking to their own suppliers/brokers if necessary.

RFU - webinar resources



A few years old now but still relevant, a three page <u>infographic</u> produced by Sport England which includes a number of energy/utility efficiency pointers to consider for your club/grounds.

The National Energy Foundation YouGen website offers free, independent advice on efficient energy usage and installing sources of renewable energy. This is their <u>Find an installer search</u> <u>directory</u> to find trusted companies who specialise in renewable energy technology.

GOV.UK's Energy Technology List if planning new plant equipment. It covers independently verified energy-efficient products such as boilers, lighting, air conditioning and refrigeration equipment.

As well as our own <u>RFU grant finder tool</u> there are many government schemes which offer loans, grants or subsidised energy-saving measures to support small businesses with reducing their impact on the environment. Search <u>GOV.UK business finance and support finder</u>. And finally there is also the <u>Grants Online</u> website to search for grants in your area.

G&T project - Energy



The Governance and Business Transformation project (G&T) funding will allow us to complete Display Energy Certificates (DEC) assessments with a small cohort of clubs - details to follow of which clubs

Following a DEC assessment and supplementary advisory report, clubs can contact relevant specialist in those recommendation areas for a competitive quotation

DECs are designed to be publicly displayed, highlighting the year on year energy performance of a building with the aim of improving its energy efficiency. Once the DEC has been initially completed, in the subsequent years they can be updated (without a site visit assuming no building changes have occurred) allowing the club's progress to be reported and support a club with a energy reduction action plan.

Unscrupulous Energy Brokers - reminder



VAT on fuel and power

Clubs are still being contacted by 'Utility Consultants/Brokers' who are suggesting clubs are paying too much VAT/ Climate Change Levy (CCL) on their fuel and power costs. This is extremely unlikely to be the case as the VAT rules for reducing the VAT rate charged are extremely restrictive and strictly only apply in certain circumstances.

We believe this stems from confusion by the brokers especially around the status of CASCs
