Sharing information outside the UK

Where necessary, we may transfer personal information outside of the UK. When doing so, we comply with the UK GDPR, making sure appropriate safeguards are in place.

How the transfer complies with UK data protection law: The main hosting servers on which Brevo processes and stores its databases are located within the European Union, specifically on Google Cloud Platform (GCP) in Belgium (and for the DACH market, in Frankfurt).

If there are any transfers outside of the EU, they will only be made in the context of the services Brevo provide to us and in compliance with the GDPR. The countries for which a transfer of data could be made are the United States, India, and Canada. When such transfer is necessary to perform their support tasks, the transfer consists exclusively of remote access to the data by Brevo's employees, to achieve two precise purposes (customer care and maintenance), in situations that are identified and limited according to the principle of data minimisation.

As part of Brevo's support 24/7, personal data may be processed by Brevo's employees of Brevo's affiliate companies located in the US & Canada (Brevo Inc) and in India (Silver Line). Those affiliates are 100% owned and controlled by Brevo France. Personal data is also processed by Brevo's external sub-processors, the list of which can be found in the applicable Brevo DPA.
